- Stock of the Redeemable Products are limited, and the Claim will only be valid strictly while stocks last. Once stock of any product included in the Promotion has been exhausted, no further Claims for that Redeemable Product will be accepted.

### DELIVERY OF REDEEMABLE PRODUCT:

- 19. A Redeemable Product will be sent directly to the postal address advised by you in the Claim. You are responsible for ensuring that you enter the correct address and Minelab cannot be held responsible for, and have no liability to reissue, any redeemed products which are delivered to an incorrect address. If you cannot provide a valid street address, or Minelab are unable to (or decide not to) deliver to your street address, Minelab will deliver your Redeemable Product to the nearest Certified Minelab Dealer.
